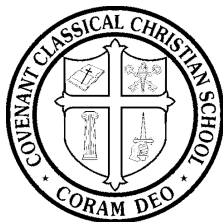

ARTICLE III - BASIS

The basis of Covenant Classical Christian School is the Word of God as interpreted in the Westminster Catechisms and Confession. The government of Covenant Classical Christian School is subject to the Session of Covenant Presbyterian Church. Moreover, this organization is committed to the following educational principles:

- (1) Christian education has its foundation in the Creator-creature relationship taught in the Scriptures (Colossians 1:15-17). It is understood as a process wherein a child's personality is formed by instruction in the truth of God and human knowledge leavened with that truth.
- (2) The responsibility for education rests upon the parents (Deuteronomy 6:6-9, Ephesians 6:1-4). They may delegate a part of this responsibility to an institution, which is able to carry forward their God-given task. The authority of the teacher in discipline and character training is derived from the fact that he stands in behalf of the parents; and the teacher derives authority in subject matter from faithfulness to the laws of God revealed in His Word and creation.
- (3) The child is first of all a spiritual-physical being, created in the image of God, capable of and responsible for learning, knowing, and obeying the truth of God's Word and the laws of His creation. He is, at the same time, a social being standing in relation to his fellow man, having moral, intellectual, and emotional needs.
- (4) The curriculum of the Christian school is the medium through which the child is oriented to a life in Christ and to the culture of this world for fellowship with and service to God in this life and the life to come.

We agree to submit with this enrollment application any achievement testing results our child has received in the last two years as well as his/her most recent report card grades. We also agree to submit with this enrollment application any psychological evaluation ever administered to our child. These forms will be placed in the student's records file while in attendance at CCCS.

We agree to submit with this enrollment application a written statement explaining any formal disciplinary action with which my child has been charged.

We have read Article III of the constitution of Covenant Classical Christian School and desire that type of education for our child.

We absolve the school from liability to us or our child because of any injury to our child at school or during any school activity.

We give permission for our child to be spanked, if necessary, in the presence of a witness. A spanking will not be used at an age inappropriate to the child's development. Discipline alternatives will be provided.

We recognize that Covenant Classical Christian School has the right to remove a child from the school at its discretion.

We agree that Covenant Classical Christian School has permission to use photos of my child(ren) in its promotional materials (website/brochures). If you do not agree to this please check here.
